Arroyo Vista Charter School - LCAP Survey 2022-2024 LCAP (Local Control Accountability Plan) What are the most important goals, actions, and services our school should consider in order to support all students over the next 3-year LCAP? What should be updated? Our Current goals are the following:

- 1. AVCS will ensure all students, including students that are English Learners, Low Income, and Foster Youth, have access to a rigorous and differentiated content-rich curriculum that supports their acquisition of advanced literacy and numeracy skills and is aligned to the expectations of the state standards.
- 2. AVCS will ensure increased student achievement on rigorous academic standards in all areas and will leverage technology to maximize student achievement.
- 3. AVCS will ensure students have access to a well-rounded curriculum that focuses on the whole child.
- 4. AVCS will ensure a positive school climate that maximizes students' social emotional and academic success in which there is high parent and student engagement and where students and families feel safe, secure, and connected. Please give us your input on the following questions...
  - 1. What is your role in our school? Parent/Guardian Community Member Student Classified Staff Certificated Staff Administrative/Non-Represented
  - 2. Service Learning or learning that is applied in the community to help others should be an important part of the AVCS student experience.

  - 9. We can improve involvement from under-represented groups by funding outreach to them. (English Learners, Low Socio-Economic, Foster Youth, Homeless, etc.)
  - 10. What are the most important goals, actions, and services Arroyo Vista Charter School should consider to support all students over the next 3-year LCAP?

## Full day TK/ Full day DI TK

- -Where will we house two full day TK classes? Will we be getting a portable? We will use the current TK classroom and another room that is currently being used for Kindergarten (Most likely the center classroom). We will probably not get a relocatable classroom this year.
- -If the second TK takes over a kindergarten classroom, where will the kindergarten classroom be housed? Kindergarten has a legal square footage requirement under Ed Code (1350 square feet) and a requirement for a bathroom WITHIN the kindergarten complex. In collaboration with facilities, it has been confirmed that the legal square footage requirements under Ed Code are for new construction. We will do what most school in our district have done with their facilities. We will adapt our current facilities to the needs of our community and programs.
- -If TK is housed in a portable, do they have the same square footage and restroom requirements as Kinder? Will there need to be plumbing installed? TK requirements are the same as Kindergarten. We will probably not be getting a relocatable classroom this year.
- -The middle classroom in the 500 building is under 800 square feet and currently houses 25 students. What will be done about that next year?

  The middle classroom in the 500 building will likely be used for TK.
- -Will the DI TK be grandfathered in to Kinder DI? That will potentially take up an entire DI class plus the current grandfathered students, leaving very little room for incoming kindergarteners.

The DI TK are not mentioned in our current charter. They will not automatically roll into the Kindergarten DI program.

-When parents express interest in TK DI, there needs to be full disclosure of the added learning demands on the children, as well as the added support needed by families, so that there is more stability in the numbers and less movement out of the program.

Yes. We have an extensive presentation that explains this.

FUTURE AGENDA ITEM: Ongoing concerns with the second strand of DI.

Next year we will be forced to lay off or push out an experienced EO teacher. Allison Workman is lowest in tenure. The following year we will force out Delia. The following year we will force out Hilary and then Arnold. Many teachers believe it is important to put some names to the people that are going to be forced out as we push through a second DI strand.

We are employees of the district, not of a particular school site. We serve in our positions for students and families. No one has been or will be "layed off." So far, no one has been displaced from our site, though that could be a possibility.

-What percentage of current DI students are zone transfers?

The current Kindergarten class has about 25% Zone transfers. Without the second strand of DI, 12 students from our attendance zone that chose to be in a DI classroom would not have had that opportunity.

-When the second DI strand reaches  $4^{th}$  grade, 20 students will be pulled out of English Only (EO) classrooms, forcing the remaining classes into combos across the board. In one scenario, possibly. We cannot pretend to know what enrollment will look like in two years. We do have other models where in the upper grades, a DI teacher can share students with EO teachers.

- Is this really what is best for EO students?
- Yes. This is clearly what is best for all students. Providing this option to more EO students will give them more options in the future. Two-way immersion is also a proven best practice for English Learners.

- Is this what the EO parents want? Are EO parents aware of the ramifications of the second DI strand?
  - It is what a considerable number of EO parents chose for their children, so yes. It is what they want. Most parents are aware enough to want to choose what they feel is the best fit for their child.

- Is the 1 on 1 attention possibly as high in a combo as it is in a straight grade?
  - o It may be possible, but not likely.
- Is this what the staff wants? Is the staff aware of the ramifications of the second DI strand?
  - o I am confident that the staff will want to do what is best for students.
- Can this be a topic of discussion as an entire staff, such as during a staff meeting?
   Certainly.

Having small group discussions between grade levels or small groups of colleagues don't facilitate communication well.

Inherently, small groups facilitate better communication and deeper discussion. That is why we have the small groups.

### We haven't had a real staff meeting all year.

We have had many real staff meetings this year. We have covered many topics that have been required by the district, taking care of business and curricular areas of focus. Because of duress caused by Covid and adjustments to safety measures, we have limited the number of times we have met both overall and in person.
