 - What interventions are being done at this point? Matthew Pare
 - Instead of suspension is to have an alternate setting for student
 - Have a staff member to supervise the student (staffing provided by district)
 - Some other activities
 - There is also potential liability on school if this continues.
 - "What is required for expulsion?" Ann Marie Kolaric
 - Repeated offense of physical aggression, bringing weapons to school, infraction taking place
 - "Who decides if a placement is not correct for a student, or a class, or a teacher?" -Ann Marie Kolaric
 - Typically, the district would present that information to the family, but it is a bit more complicated depending on that recommendation is
 - It's a process
 - Were there ever physical incidents?
 - \circ $\,$ Yes, if another incident happens. This will be a clear case of liability to the school
 - "What kind of training are you giving the teachers/staff?" Kerri Lindgren
 - All teachers have been trained in SEL, crisis, but to deal with a specific violent outburst in their classroom, they have not
 - o AVCS has about 4-5 teachers trained
 - $\circ~$ A few more of our staff members will be getting this training

- \circ $\:$ In the past, teachers have been CPI trained, but they would have to leave their classroom
- We will have our school counselor work closely with the classroom teacher to support trauma
- G. School Cafeteria and Lunches
 - Many of the choices are taken by the time that 6th graders are coming to eat.
 - This is an issue that we will have to continue to deal with since we don't have lunch count
